## **Position Overview:**

The Director of Health reports to and work closely with the Board of Directors for administrative guidance and direction.

# **Minimum Requirements:**

- A master's degree in public health from an accredited college or university or an
  M.D. with a master's degree in public health with training and experience.
- Four (4) years of professional experience in environmental or public health administration.
- Two (2) years of senior level/supervisory or management experience.
- Eligibility for appointment approval by the Commissioner of Public Health.
- Exceptional leadership, communication, collaboration, and mentoring skills.
- Understanding of public health principles, epidemiology, health promotion, and legislation.
- Fiscal management skills, including budgeting, oversight of financial reporting, and establishing cost containment strategies and measures.
- Proficiency in data analysis, research methods, and evaluation techniques.
- Motor Vehicle Operator's License that is valid in Connecticut.

- Professional, team-oriented, with opportunities for autonomous work.
- Office and field work with exposure to various weather conditions and potential hazards.
- Flexibility to work additional hours and attend meetings outside regular work hours.
